DIRECTIONS

FROM POINTS WEST: Take your best route to I-70E toward Frederick. Take exit 52B to merge onto US-15N/US-340E toward Gettysburg. Take exit 11 for MD-351/MD-180/Ballenger Creek Pike toward Jefferson Pike. Turn right onto MD-180W/MD-351N/Ballenger Creek Pike. Go 0.2 miles and turn right onto Himes Avenue. Go about 0.5 miles and restaurant will be on the right.

FROM POINTS EAST: Take your best route to I-70W toward Frederick. Take exit 53B to merge onto I-270N/US-40W toward US-15N/Gettysburg. Go 0.7 miles and take the Jefferson Street exit toward US-15S/US-340. Turn left onto US-340W. Go 0.2 miles and take the MD-180 exit toward MD-351. Keep right at the fork to continue toward Himes Avenue. Make a slight right onto Himes Avenue. Go about 0.5 miles and restaurant will be on the right.

FROM POINTS SOUTH: Take your best route to I-270N toward Frederick. Take the Jefferson Street exit toward US-15S/US-340. Turn left onto US-340W. Go 0.2 miles and take the MD-180 exit toward MD-351. Keep right at the fork to continue toward Himes Avenue. Make a slight right onto Himes Avenue. Go about 0.5 miles and restaurant will be on the right.
