DIRECTIONS

FROM POINTS WEST: Take your best route to I-70 East. Take Exit 68 for MD-27 N toward Mt Airy. Turn left at MD-27 N/Ridge Rd and continue for 19.5 miles toward Westminster. At cloverleaf, take MD-140 W toward Taneytown. Turn left at the 4th traffic light onto WMC Drive (Western Maryland College Dr). Best Western is on the corner of MD-140 and WMC Drive.

FROM POINTS EAST: Take your best route to US-50 West. Take Exit 27B and merge onto MD-2 N/ Baltimore Annapolis Blvd toward Ritchie Hwy/Severna Park. Continue to follow MD-2 N for 8.4 miles. Merge onto MD-10 N via the ramp to MD-100 W/I-695/Baltimore and continue for 7.0 miles. Take the I-695 W/MD-2 N exit toward Baltimore/Towson. Keep left at the fork to merge onto I-695 W and continue for 15.5 miles. Take exit 19 to merge onto I-795 N/Northwest Expy toward Owings Mills/ Reisterstown and continue for 9.7 miles. Continue onto MD-140 W and go 12.9 miles toward Westminster. Turn left at WMC Drive (Western Maryland College Dr). Best Western is on the corner of MD-140 and WMC Drive.

FROM POINTS SOUTH: Take your best route to I-270 North. Take exit 16 for Father Hurley Blvd toward MD-27/Damascus. Keep right at the fork to merge onto Ridge Rd and continue for 7.5 miles, then turn left at MD-27 N/Ridge Rd. Continue to follow MD-27 N for 24.9 miles toward Westminster. At cloverleaf, take MD-140 W toward Taneytown. Turn left at the 4th traffic light onto WMC Drive (Western Maryland College Dr). Best Western is on the corner of MD-140 and WMC Drive.
