

On Saturday, April 17th— Join the Maryland Juniors at 10:00 a.m. as they celebrate their accomplishments at Junior Day. All Maryland Clubwomen are invited to attend this energized meeting and the Junior/General Luncheon, "A Spoonful of Love." The program will feature the presentation of Youth Art Awards. The 2010-2012 Junior Officers will be elected and installed.

On Saturday Evening— All Club Presidents will be honored as our members gather for the District Presidents' Reception at 5:15 p.m. The official opening of the Convention will be the "Everything's Coming Up Roses" Banquet at 6:30 p.m—highlighted by the parade of Club Presidents and the District Presidents' reports. Babs remains active at all levels of Federation, serving as advisor to a Juniorette club, which she started in 1994, chairman for her district, chairman

for her Junior and General clubs, advisor on the Junior state level, and as the webmaster of GFWC Maryland's website. A Jazz Trio featuring Karla Chisholm will entertain at the "Everything's Coming Up Roses" Banquet on Saturday, April 17th. A charming Southern Belle in both manner and spirit, Karla Chisholm was born and raised in Dallas, TX, and studied vocal performance at the storied music program at the University of North Texas. After stints in Washington and Los

Angeles, she now makes her home on the west side of Baltimore, not far from the old vaudeville theaters and chitlin circuit clubs where Billy Holiday cadged drinks from lovestruck hustlers and sang her soul out to the salty-aired night. Karla plays gigs all over the Baltimore-Washington area, including spots with musicians who regularly round out sessions with the likes of Prince, Justin Timberlake, Al Dimeola, Bebe Wynans and Eva Cassidy. At 18, Karla debuted at Switzerland's famous Montreux Jazz Festival. In 2009, she shared a stage with Mary Wilson of the Supremes. She has toured in the Greek Isles and Dubai, but feels just as comfortable reinvigorating the standards in front of a hometown crowd at Baltimore's Federal Hill Jazz and Blues Festival. 


The Bel Canto String Quartet will entertain at the "Wind Beneath Your Wings" Banquet on Sunday, April 18th. Based in Southern Maryland, the Bel Canto String Quartet was founded in 2004 by Neil Puzon and Gabe Soloff as an opportunity to read chamber music. Since then, the quartet has evolved and participated in educational outreach programs

and performed for numerous events. Faculty members of the U.S. Navy War College called them "a class act" and "the best we've heard." Performances have included the Library of Congress Whittall Pavilion, Mattawoman Creek "Arts in Park" Festival, and the Lurman Summer Concert Series. They've also appeared at the White House Military Office and the French and Italian embassies. Members have studied chamber music at the University of Maryland, Temple University, and Yale, and with various prestigious ensembles including the Julliard and Sunrise string quartets. They continue to be acknowledged for their technique and exciting repertoire.

Elaine Weiss, author of "Fruits of Victory," will be the featured speaker at the "Turning the Page" ESO Luncheon on Monday, April 19th. Elaine Weiss, who has written for such publications as the New York Times and Harper's, chronicles the largely forgotten history of the Woman's Land Army (WLA) in "Fruits of Victory." This group of U.S. women left their homes and college dorms in droves to volunteer when American involvement in World War I called young men from the fields to the trenches of Europe. Weiss shows how these "farmerettes" faced an uphill battle, as they were often met with disdain by shorthanded farmers and Washington politicians who did not feel the situation was dire enough to warrant hiring women to do men's work. WLA architects, many of whom earned their stripes in the suffrage movement, developed a blueprint for managing a group anywhere in the U.S., and they were able to secure wages—and an eight-hour workday—equal to their male counterparts. The group disbanded after the war, but the farmerettes helped pave the way for women working during World War II. Elaine lives in Baltimore with her husband, Julian Krolik, a professor of astrophysics at Johns Hopkins University. They have two children.

# SELECTING CLUB DELEGATES

# **HOW** to Select Club Delegates to Convention

Each year, when clubs submit names for their CLUB DELEGATES to Convention, there is usually some confusion and questions. The following guidelines will assist you in selecting your CLUB DELEGATES:

- 1. VOTING members of the Convention automatically include:
  - State Officers
  - District Presidents
  - Honorary Presidents
  - Club Presidents
  - State Department & Program Chairmen
  - State Standing & Special Committee Chairmen
  - Staff of The Maryland Clubwoman Magazine

Any clubwoman holding one of the above positions is a member of the GFWC-MD BOARD OF DIRECTORS, as listed on pages 8-24 of the GFWC-MD Directory.

- 2. If one of your members holds any of the above positions, do NOT appoint them as a CLUB DELEGATE to the Convention. If you do, your club will LOSE a vote.
- 3. VOTING members of the Convention also include CLUB DELEGATES. The number of CLUB DELEGATES to which your club is entitled is defined in the GFWC-MD Bylaws and is based on your club's membership. Membership is determined by the number of club members who have paid their dues by February 1, 2010. You are allowed to appoint ONE (1) CLUB DELEGATE for every 25 members, or major fraction thereof.
- 4. No member is entitled to more than ONE (1) VOTE. Even though a member may hold more than one position on the BOARD OF DIRECTORS, she may only VOTE ONCE. The Federation Bylaws say, "A voting member shall have but one vote, although entitled to vote in either of several capacities." Example: If a member is a State Chairman and also a Club President, she may vote as one or the other, but not both.
- 5. DELEGATE VOTING STRENGTH is often confusing to members attending Convention. If your club has members on the GFWC-MD BOARD OF DIRECTORS, your club will not receive recognition for their attendance, since NO DUPLICATION is allowed.
- 6. It is an honor to serve The Federation. Members who are appointed to the GFWC-MD BOARD OF DIRECTORS, or who are selected as a CLUB DELEGATE, should carry out their duties with great pride. Do not minimize the importance of these responsibilities.

A Registration Fee will be charged for all attendees, regardless of voting status or length of attendance. Everyone attending MUST register and pay the Registration Fee. *The Pre-Registration Fee of \$8.00 MUST BE MAILED to the Credential Chairman, Judith Tippett, by March 22, 2010, along with the Registration & Credentials Form (on page 13 of the Special Convention Pull-Out Section).* An On-Site Registration Fee of \$10.00 will be collected for anyone not Pre-Registered. You will receive your badge upon arrival at the annual convention. No one will be admitted to the meetings without a badge. Members who belong to more than one club must decide which club they will be registered under.

## **Club Delegates:**

Your Club President should fill out the Registration & Credentials Form (on page 13) and mail to the Credential Chairman Judith Tippett. If your club has alternate delegates, please send their name(s) separately. The number of Club Delegates to which your club is entitled is based on the number of club members who have paid their dues by February 1, 2010. You are allowed to appoint one (1) Club Delegate for every 25 members, or major fraction thereof.

### **Junior & Juniorette Clubs:**

Your Club President should fill out the Registration & Credentials Form (on page 13) and mail to the Credential Chairman Judith Tippett.

## **Voting Members:**

"The Federation and the General Federation of Women's Clubs delegates will be based only upon those members whose dues shall have been paid by February 1." Standing Rule 2a (pg. 80). "The voting members of The Federation shall be the members of the board of directors and the accredited delegates. A voting member shall have but one vote, although entitled to vote in either of several capacities. No delegate shall represent more than one club." Article VI, Section 2 of The Federation Bylaws (pg. 75).

## **Non-Voting Members:**

All non-voting members must still register.

# PROPOSED BYLAWS AMENDMENT

# Proposed Amendment to The GFWC Maryland Federation of Women's Clubs, Inc. Bylaws

According to ARTICLE XVII: Amendments to the Bylaws, of The Federation Bylaws (page 79), "These bylaws may be amended by a two-thirds vote at any annual meeting, provided the amendment has been proposed by the bylaws committee, the executive committee, or by a federated club; and a copy of the proposed amendment has been sent with the call at least six weeks before the annual meeting. Proposed amendments must be received by the chairman of the bylaws committee on or before January 1."

The GFWC Maryland Bylaws Committee received the following proposed amendment to ARTICLE VII: Dues, Section 1, paragraph 1, of The GFWC Maryland Federation of Women's Clubs, Inc. Bylaws. We will be voting on this proposed amendment on Sunday, April 18, 2010, at the GFWC Maryland Annual Convention.

## ARTICLE VII: Dues, Section 1, paragraph 1 currently reads:

"Annual dues for active clubs shall be \$4.50 per capita in addition to the required General Federation of Women's clubs dues and these dues shall be apportioned through the budget to The Federation and the General Federation of Women's Clubs."

**Proposed amendment to ARTICLE VII: Dues, Section 1, paragraph 1:** Strike "\$4.50" and insert "\$5.50".

## ARTICLE VII: Dues, Section 1, paragraph 1 would then read:

"Annual dues for active clubs shall be \$5.50 per capita in addition to the required General Federation of Women's clubs dues and these dues shall be apportioned through the budget to The Federation and the General Federation of Women's Clubs."

Our first meeting was a "Meet and Greet" Potluck Luncheon that featured a large variety of both hot and cold dishes and delicious desserts. We expect many of them to be featured as recipes in our upcoming Cookbook. Among the 80 in attendance were new members who had previously been hosted at a New Member Brunch. After officers and committee chairpersons outlined what had been planned so that members could decide on what committees they would work on, we were delighted to hear from our Anne Arundel Medical Center Nursing Scholarship winner, Patricia Drake, RN, a single mother of three. She told us how much she appreciated the monies she received out of our \$5,000.00 annual donation to the Anne Arundel Medical Center Foundation, without which she could not continue her nursing education. A coupon box was set up in our Community Lodge so our members and residents of Heritage Harbour could help collect coupons for military families at Fort

Meade and bases overseas. Later, another carton was used to collect 2010 calendars requested by hospitalized veterans. Twin-sized sheets for Hospice of the Chesapeake was also on our to-do list. However, we also planned a year-long series with the specific aim of "empowering the minds, bodies, and spirits of our members." Our first presenter in October was Karen Kansler, RN, an outreach worker at Good Samaritan Hospital in Baltimore. Karen established the "Vintage Program" to spread the word to older adults about how to live longer, useful lives.
