119th Annual GFWC Maryland Convention and General-Junior Meeting April 21-22, 2018 in Columbia, MD

The 119th Annual GFWC Maryland Convention and General-Junior Meeting was held at the Sheraton Columbia Town Center Hotel in Columbia, Maryland with GFWC Maryland President Reno Eitel and GFWC Maryland Director of Junior Clubs presiding. The convention combined the themes of President Eitel, "Women Creating Positive Change...Living the Volunteer Spirit" and Junior Director Wagman, "Broken Crayons Still Color" for the first combined Junior-General annual meeting for Maryland Clubwomen.

PRESIDENT'S SIGNATURE PROJECT: DOMESTIC VIOLENCE

According to Google, the definition of domestic violence is “a violent or aggressive behavior within the home, typically the violent abuse of a spouse, partner or relative”.

Domestic violence has become a huge umbrella of violent acts against another:

- physical acts within a “family”
- sexual assault
- human trafficking
- elder abuse in nursing complexes by caregivers
- continual verbal abuse
- deaths by abuse in the workplace

Here are some interesting facts regarding domestic violence in MD. (<https://mnadv.org/resources/get-the-facts/>)

- There were 46 domestic violence deaths in MD last year.
- In one day, 956 victims of domestic violence were served.

Sexual assault has declined due to the increased reporting and consequences for the perpetrator. Some interesting facts have emerged. (<https://www.rainn.org>)

- Of sexual abuse cases reported to law enforcement, 93% of juvenile victims knew their perpetrator.
- 59% were acquaintances.
- 34% were family members.
- 7% were strangers to the victim.

How do MD clubs get involved?

1. Schedule speakers from Family and Children Services or Rape Crisis Intervention Services.
2. Support the local safe house and collect items for their various needs.
3. Man the hotline for domestic violence or Rape Crisis Intervention Service.
4. Educate club members about the growing problem of human trafficking. Contact the MD Task Force of Human Trafficking.
5. Get more involved in your local community.

You can make a difference by being educated and involved with the great dangers and consequence of domestic violence.

JUNIOR'S SIGNATURE PROJECT: ADVOCATES FOR CHILDREN

President John F. Kennedy said “children are the world’s most valuable resource and its best hope for the future.” As your Women’s, Junior and Juniorette clubs start meeting, put your heads together to brainstorm projects that support and advocate for children. The goal is to find projects that ensure children are protected from harmful situations, encourage physical and mental health, and that impact policy to improve children’s lives.

A few project ideas include:

- Ask members to donate items such as coloring books, playdoh, puzzles and small toys to take to your local pediatric unit to support pediatric playtime.
- How about furniture safety? Plan a program at your club meeting to raise awareness in your community and help save a child’s life by sharing the dangers of furniture tip overs and other hazards in the home. Purchase and distribute anchoring kits to secure heavy furniture.
- Plan a program around screen time awareness. In this age of digital media, children are being exposed to electronic screens as early as infancy. Too much screen time for children can lead to issues such as obesity, irregular sleep schedules and behavior issues. Find a fun and creative way to educate your club members of the new guidelines for screen time.

Mark your calendars for GFWC Advocates for Children Week 2018 which runs from October 21 - October 27. Club members are encouraged to plan events for that week that relate to the Junior Special Program. Recycle an old project or try a new project.

St. Jude Children’s Research Hospital is one of GFWC partners. Support the St. Jude walk/run to end childhood cancer by joining the GFWC National team or by forming a team in your club. Attend the National walk in Baltimore September 22, 2018 or do a virtual walk with your club in your community. ([you can register at stjude.org](http://stjude.org)). Sponsor a Trike-A-Thon in your community. This is a service learning program for daycares and preschools that teaches trike riding and riding toy safety while supporting St. Jude.

March of Dimes is our other GFWC partner. Premature birth is the #1 killer of babies in the United States. Here are some projects to support March of Dimes:

- Have your club members provide a special baby blanket for the babies of military families. The blankets can be handmade, sewn or the no-sew blankets, knitted, crocheted or quilted.
- March for Babies! Make a team of your club members to walk and set a fundraising goal to support March of Dimes.
